The Board of Trustees held their rescheduled meeting on Tuesday, February 17, 2015 as posted. CALL TO ORDER

SUPERINTENDENT REPORT

Budget Status (1/31/15) – Superintendent reported that in February another state payment will be made and about \$25,000.00 of levy funds left to be sent by the Counties. Discussion of building levy funds need to be transferred to Plant Facility account to cover future building expenses needed to include: HVAC, Roto Rooter maintenance service, electrical and plumbing concerns.

BOARD TRAINING (2/18/15) – The Goals Meeting will be at the Lewiston Red Lion from 8:00 a.m. until 3:00 p.m. The ISBA trainer will not begin the Strategic Planning training until 9:00 a.m. The process will use the WISE Tool for school improvement to begin the continuous improvement plan for the school. The trainer will be Jackie Hopper.

Food Service Report- Revenue is at \$24,000.00 and expenses of \$27,500.00. The difference with use of the #3760.00 Fund Balance puts the account just a little under. Superintendent will talk with Head Cook/Manager Pam Phillips to help bring down the monthly cost of expenses.

HVAC Update – The electrician still needs to get back to me on an estimate.

Chairman requested some building upkeep/cleaning services be done such as the roof, gutters and drains. Mr. Martin asked the Superintendent to contact Gutter King for screens to be installed on the school gutters. A recommendation for renting a man lift will help to complete these requests

PRINCIPAL REPORT

Supt. Felgenhauer read the report as submitted by the Principal.

Enrollment is 93 students with P-5th grades at 49, 6^{th} -7th at 24 and 9th - 12th with 20.

Students of the Month Awards-Secondary student receiving the award is Elizabeth Babcock and the Elementary student is Alexus Williams.

Activities/Events - Geography Bee winner is Elizabeth Babcock. The Spelling Bee winners were 1st place-Courteney Hart, 2nd place-Elizabeth Babcock and 3rd place-Jasmine Miller. Colton Dudley and Syria Fuhrmann were each awarded \$75.00 for their essays for the "Why I am Proud to be an American" essay contest through the Fleet Reserve Association. Five girls are playing Junior High Volleyball with Highland. Boys District Basketball Tournament starts at LCSC Gym tonight.

Intervention Position- This staff member is helping out tremendously with one to three students per day.
