## STATE OF IDAHO RETIRED ADMINISTRATOR CONTRACT

THIS CONTRACT is made this 8<sup>th</sup>, day of April year of 2020, by and between Culdesac Joint School District No. 342, Culdesac, Idaho ("the District"), and Alan Felgenhauer ("the Superintendent") at .49 FTE, provided that the Administrator certifies that he or she has not received any state-funded early retirement benefit. Past receipt of such benefit makes the Administrator ineligible for employment in a certificated capacity, pursuant to Section 33-1004H, Idaho Code, and automatically renders this Contract null and void.

#### WITNESSETH:

- 1. The District hereby employs the Superintendent pursuant to Section 33-1004H, Idaho Code on a limited two fiscal-year at-will basis, to perform the duties of Superintendent so designated by the District and to perform such other duties as specified by the District at any time during the term hereof, provided that the Administrator is properly certified and endorsed to perform said duties, solely for the duration of the 2020-2021 and 2021-2022 fiscal years, consisting of a period of eight days per month, and agrees to pay the Administrator for said services a sum of Forty-two Thousand Dollars per year (\$42,000.00), of which \$3,500.00 shall be payable on the 20th day of the months July, year of 2020, to June, year of 2022, inclusive, and such other benefits as indicated herein.
- 2. In consideration of the promises and agreement of the District recited herein, the Administrator agrees to assume the duties set forth above at Culdesac School on 600 Culdesac Avenue, Culdesac, Idaho, 83524 on July 1st, in the year 2020, and to faithfully perform and discharge the same to the best of his/her ability and as directed by the District and to comply with the applicable laws of the State of Idaho, the duly adopted rules of the State Board of Education, and such regulations, directives and policies as the Board of Trustees may legally prescribe which are, by reference, incorporated in and made a part of this agreement the same as if set forth herein.
- 3. The parties hereto agree that this is a two-year Contract entered into pursuant to Section 33-1004H, Idaho Code, and is limited in duration to the fiscal years set forth above, and that no property rights attach to this Contract beyond the term of this Contract. No further notice is required by the District to terminate the Contract at the conclusion of the second fiscal year, and such Contract will automatically terminate on June 30, 2022, end of the fiscal year. This contract does have a one (1) year opt out option. If either party notifies the other, in writing, before the January 2021 meeting, the contract will terminate on June 30, 2021. Both parties agree that NO penalty or damages will be assessed if the early termination option of the contract is utilized.
- 4. The Administrator will accrue one (1) day of sick leave per month of the contract period. Sick leave will not accumulate beyond the contract period for use in subsequent contracts entered into with the District by the Administrator. No sick leave accrued pursuant to this Contract shall qualify for the unused sick leave benefit as provided in section 33-1228, Idaho Code.
- 5. The District will provide the following benefits to the Administrator during the contract period:
  - Cell phone allowance of \$25.00 per month for the duration of the contract due to the on-call nature of the position. Monthly mileage/lodging reimbursement as approved by the Board for the duration of the contract period.
  - One (1) day of personal leave per fiscal year for the duration of the contract.
  - Enrollment in Culdesac JSD #342 Blue Cross Group Health Insurance plan including dependent coverage with monthly premium paid by employee.
- 6. Any material false statement knowingly made in the written application for a position with the District shall constitute sufficient ground for voiding this Contract.
- 7. It is mutually understood and agreed by and between the parties, that nothing herein contained shall operate or be construed as a waiver of any of the rights, powers, privileges, or duties of either party hereto, by and under the laws of the State of Idaho, except as expressly stated in this Contract.
- 8. The terms of this Contract are separate and apart from, and do not include or incorporate, any terms of any Master Contract.
